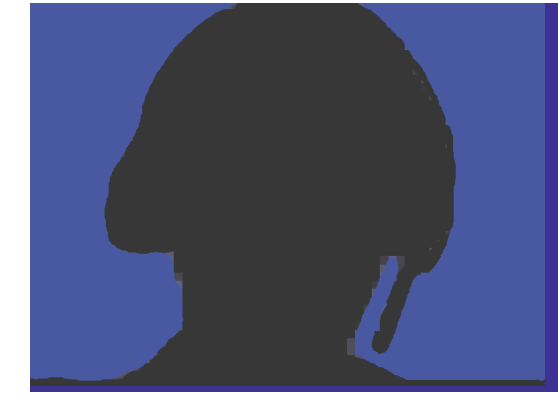




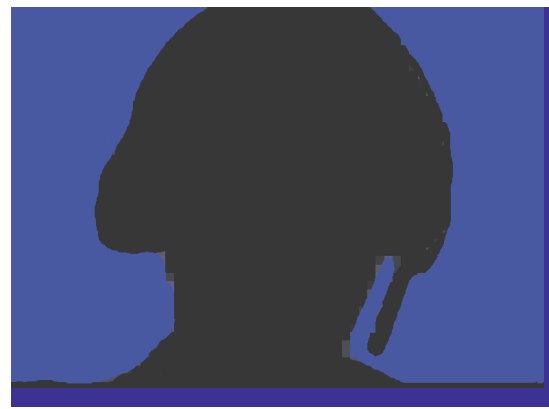
**09/20/03 Staff Sergeant Frederick L. Miller, Jr. 27 Hagerstown, Indiana**  
 Killed in Ar Ramadi, Iraq. conducting a security patrol when an improvised explosive device hit his vehicle.  
 Assigned to Troop K, 3rd Squadron, 3rd Armored Cavalry Reg., Fort Carson, Colorado



**09/20/03 Specialist Lunsford B. Brown II 27 Creedmore, North Carolina**  
 Killed in a mortar attack on Sept. 20 in Abu Greeb, Iraq.  
 Assigned to A Co., 302nd Military Intelligence Btn, Patton Barracks, Germany



**09/22/03 Specialist Paul J. Sturino 21 Rice Lake, Wisconsin**  
 Died in Quest, Iraq from a non-combat weapons discharge.  
 Assigned to B Battery, 2nd Btn, 320th Field Artillery Reg., Fort Campbell, Kentucky

**09/24/03 Specialist Michael Andrade 28 Bristol, Rhode Island.**  
 Died in Balad, Iraq, a passenger in a HMMWV when a 5-ton truck struck his vehicle.  
 Assigned to the 115th MP Co., U.S. Army National Guard, Cranston, Rhode Island.  
 The incident is under investigation.



**09/25/03 Sergeant 1st Class Robert E. Rooney 43 Nashua, New Hampshire**  
 Died at [Shuabai Port, in Kuwait](#), when he was struck by a forklift.  
 Assigned to the 379th Engineer Co., U.S. Army National Guard, based in Bourne, Mass.



**09/25/03 Specialist Kyle G. Thomas 23 Topeka, Kansas**  
 Killed in Tikrit, Iraq while on patrol when an improvised explosive device exploded  
 Assigned to 2nd Btn, 503rd Infantry Reg., 173rd Airborne Brig., based in Fort Ederle, Italy.

**09/25/03 Captian Robert L. Lucero 34 Casper, Wyoming**  
 Killed in Tikrit, Iraq as another soldier was injured when struck by an improvised explosive device.  
 Assigned to the 4th Inf. Div. Rear Area Ops Cntr, U.S. A. Natl Guard, Casper, Wyoming



**09/ 26/03 Specialist Lisa M. Andrews 24 Lenexa, Kansas**  
 Died near [Overland Park, Kansas](#) on leave from her unit when was struck and killed by a civilian vehicle.

 Assigned to the 129th Trans. Co., U.S. Army Reserve, based in New Century,



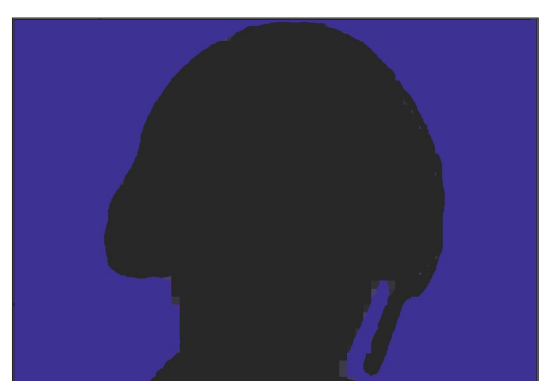
**09/29/03 Private First Class Evan W. O'Neill 19 Haverhill, Massachuetts**  
 Killed in [Shkin, Afghanistan](#) while on patrol when he was engaged by enemy forces.  
 Assigned to 1st Btn, 87th Inf. Reg., 10th Mountain Div., Fort Drum, New York



**09/29/03 Staff Sergeant Christopher E. Cutchall 30 McConnellsburg, Pennsylvania**  
 Killed west of Baghdad, Iraq when an improvised explosive device detonated as his vehicle passed by.  
 Assigned to Delta Troop , 4th Cavalry, Fort Riley, Kansas



**09/29/03 Sergeant Darrin K. Potter 24 Louisville, Kentucky**  
 Killed near Abu Ghraib Prison, Iraq.as a member of an MP team searching the prison area  
 when his vehicle left the road and went into a canal.  
 Assigned to the 223rd MP Co., U.S. Army National Guard, Louisville, Kentucky



**09/29/03 Private First Class Kristian E. Parker 23**  
 Parker died on Sept. 29 of non-combat related injuries at Camp AS Sayliyah, Qatar.  
 Assigned to the 205th Engineer Btn, U.S. Army National Guard, Slidell, Louisiana  
 The incident is under investigation.
