

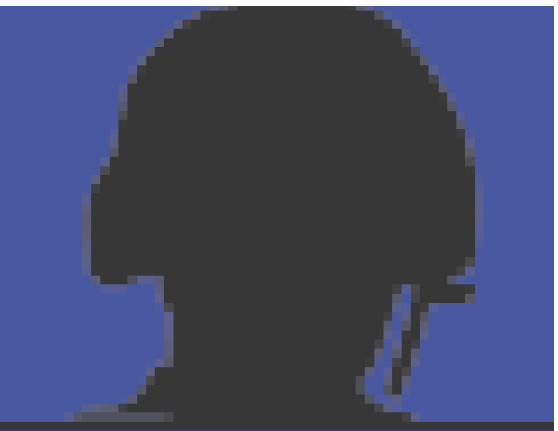

 Assigned to C Co., 2nd Btn, 325th Airborne Inf. Reg., 82nd Airborne Div., Fort Bragg, North Carolina



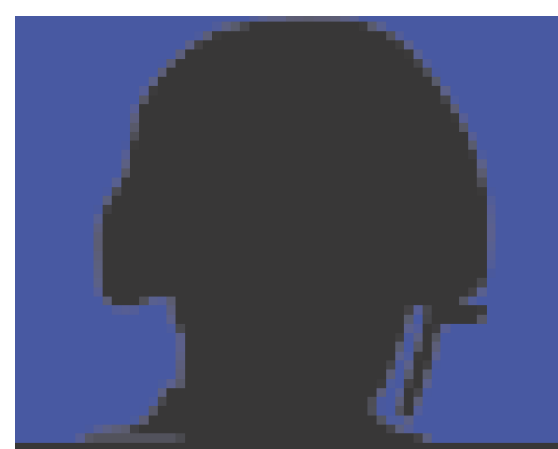
10/26/03 Private First Class Joseph R. Guerrero 20 Dunn, North Carolina

 Assigned to C Co., 2nd Btn, 325th Inf. Reg. 82nd Airborne Div., Fort Bragg, North Carolina



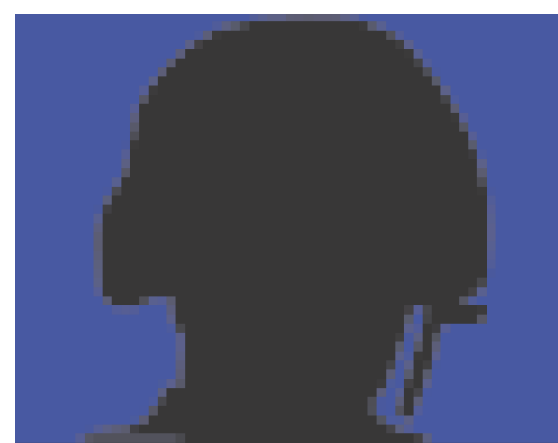
10/26/03 Private First Class Rachel K. Bosveld 19 Waupun, Wisconsin

 Assigned to the 3rd Btn, 67th Armor Reg., Fort Hood, Texas.



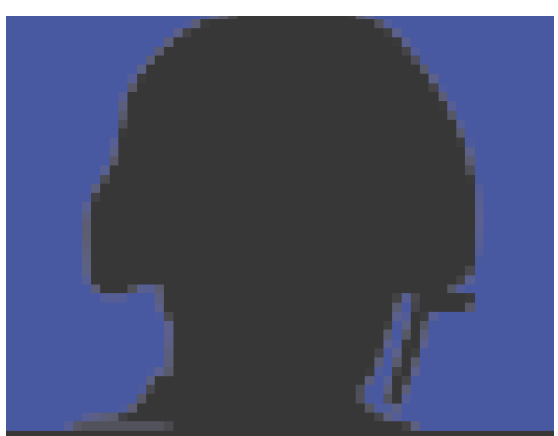
10/28/03 Specialist Isaac Campoy 21 Douglas, Arizona

 Assigned to the 3rd Battalion, 67th Armor Regiment, Fort Hood, Texas.



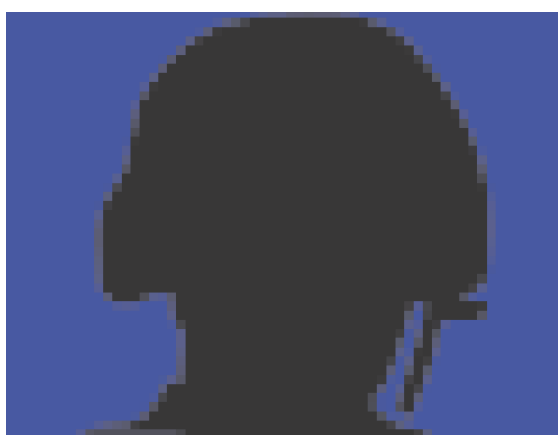
10/28/03 Private Algernon Adams 36 Aiken, South Carolina
