 Assigned to the Army's 1st Btn., 18th Infantry Reg., Schweinfurt, Germany.



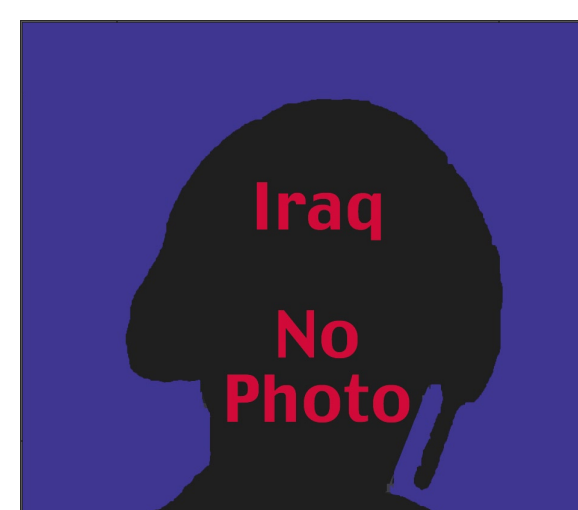

 Assigned to the 1st Btn, 26th Inf. Reg., 1st Inf. Div., based in Schweinfurt, Germany.



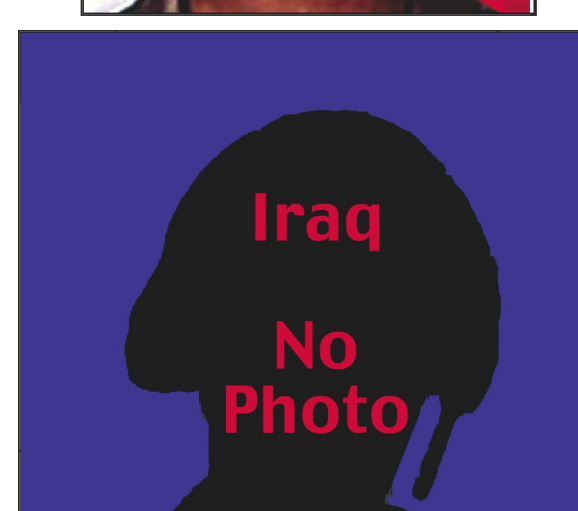
03/21/04 Private First Class Christopher E. Hudson 21 Carmel, Indiana,
