



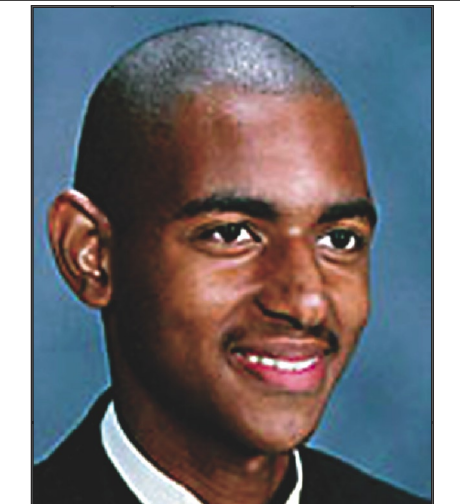

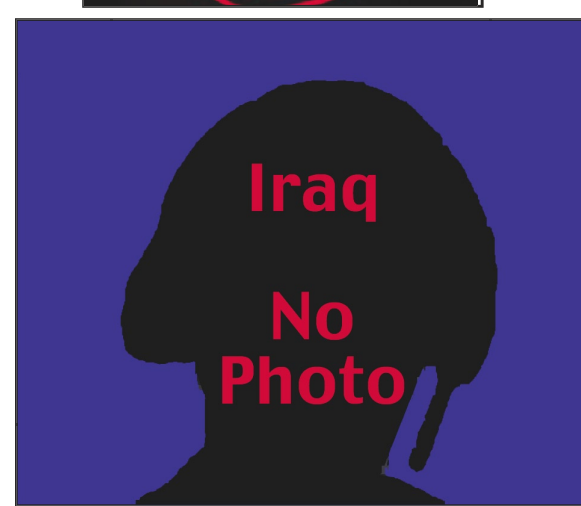
04/10/04 Specialist Justin W. Johnson 22 Rome, Georgia
