 Assigned to 3rd Btn., 7th Marine Reg., 1st MarDiv., I Marine Expeditionary Force, at Twentynine Palms, California




04/20/04 Sergeant Elmer C. Krause 40 Greensboro, North Carolina

 Assigned to the Army's 2nd Btn., 75th Ranger Reg., Fort Lewis, Wash.




