Assigned to C Company, 141st Engineer Combat Btn., North Dakota National Guard, Hettinger, N.D.



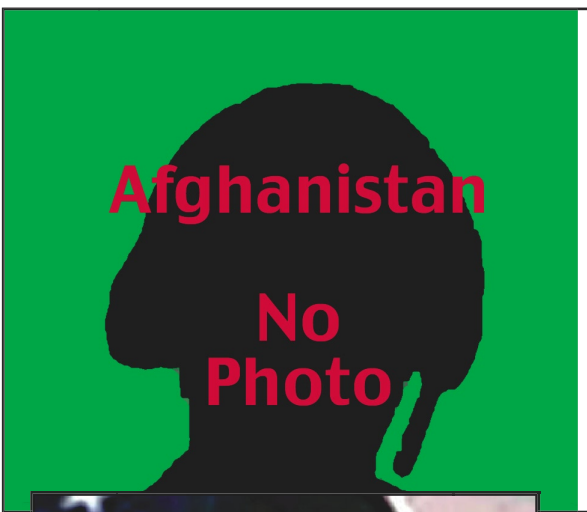
**05/08/04   Specialist Chase R. Whitman   21   Oregon**

Assigned to the Army National Guard's 1st Btn., 161st Infantry, Spokane, Washington



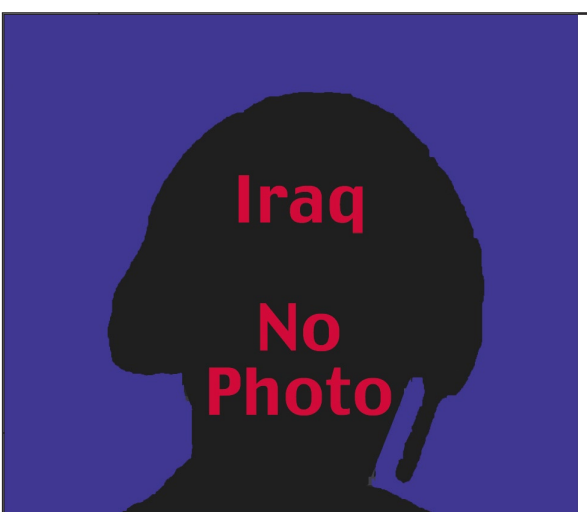
**05/12/04   Lance Corporal Jeremiah E. Savage   21   Livingston, Tennessee**
