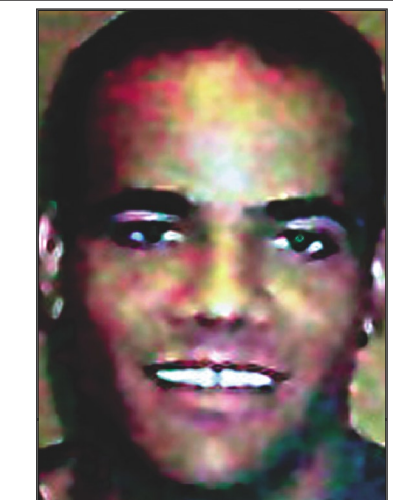

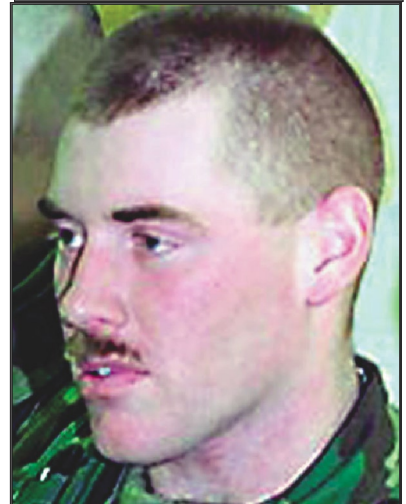

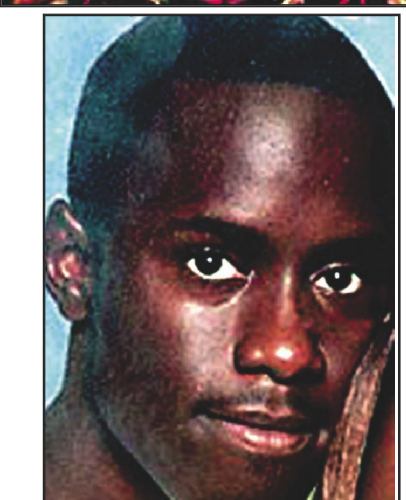
06/06/04 Private First Class Melissa J. Hobart 22 Ladson, S.C.,
