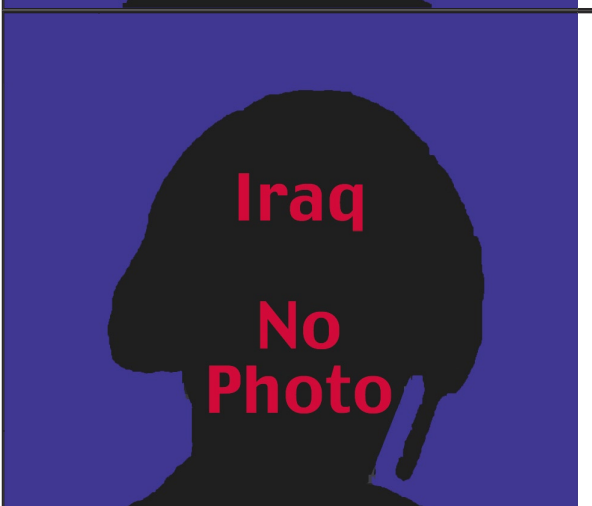




**06/13/04 Specialist Eric S. McKinley 24 Corvallis, Oregon,**

Assigned to the 351 MP Co., 95th MP Btn., 16th MP Brig., Ocala, Florida



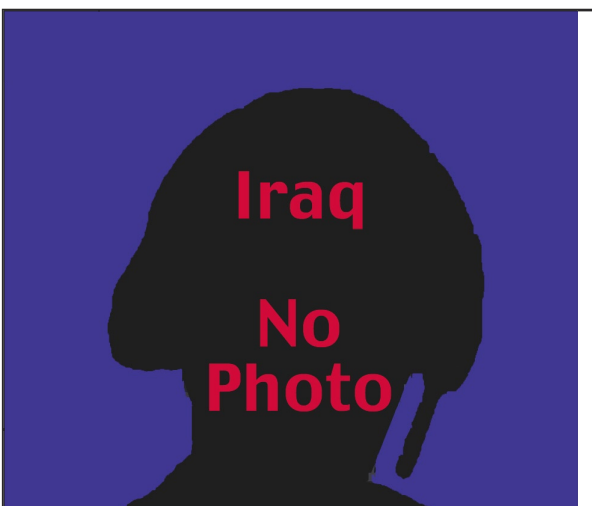
**06/16/04 Specialist Jeremy M. Dimaranan 29 Virginia Beach, Va.**

Assigned to the 5th Special Forces Group, Fort Campbell, Kentucky



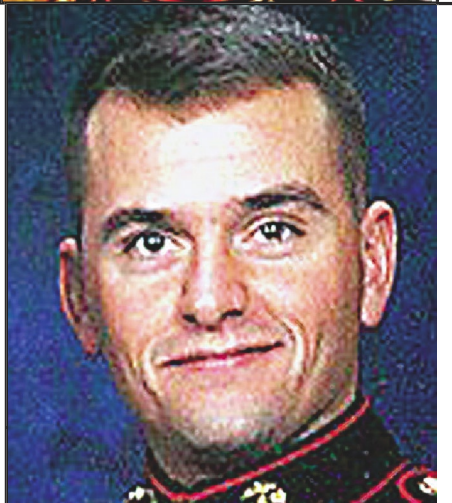
**06/18/04 Specialist Thai Vue 22 Willows, California**
